Annual Report of the Malayali Association 2018

Malayali Association (MA) was established with laid down objectives to serve as a platform for Malayalees to meet and exchange views and foster friendly relationship within as well as with local and other Indian communities.



The present committee of Malayali Association officially assumed charges on 4th March 2018 during the AGM held at Serikandi Café and Restaurant, Kuala Belait.

The committee has met 12 times for monthly meetings with an average attendance of 65%. In addition to the Management Committee, subcommittee members were also invited from the MA members, aimed to provide a platform for the community to work with the Management Committee in certain areas.

A lot of activities and programmes were organised under the banner of Malayali Association. The number of memberships has become 134 in 2016.

SOCIAL WELFARE

BEACH CLEANING AND WALKATHON

Malayali Association (MA) marked the Earth Day by organizing Beach cleaning activity in connection with World Earth Day Celebrations and a Go Green Campaign of Brunei Government, on 22nd April 2018 at 16 30 hrs at the KB Beach near Jubilee Park. CAMPING AT TROPICAL BIO-DIVERSITY CENTER



Malayali Association Organized Camping at Tropical Biodiversity Centre:-with the support of Heart of Borneo (HOB) has successfully organized 2 days Holiday Camping for children of MA community at Tropical Biodiversity Research and Innovation Centre, Labi.

Tropical Biodiversity Centre (TBC) is located at Andulau Forest Reserve and was officially launched on 23rd March 2013 situated strategically within one of the highly diverse flora species assemblage sites in this world. It also houses terrestrial biodiversity information including microbes for national references and resource provider for academicians, relevant experts and also provides facilities such as lecture room, theatre, exhibition and library.

MA conducted camping activity on 24th March 2018. The chief guest, Tuan Hj Safwan Abdullah Bibi, CEO Heart of Borneo (HOB) admired about MA's initiative to empower children by sharing Brunei's vast natural biodiversity information through this camp. He also elaborated about TBC's functioning in areas of Brunei's terrestrial biodiversity to facilitate more effective and efficient biodiversity knowledge and to promote eco-tourism.



A slide show was presented by UBD students, which gave children an awareness and importance of protecting the forests and sustain wild life wealth of Brunei.

About 30 children from MA community participated in this camp who were separated into different groups upon arrival.

The highlights of the camp include Ice breaking & team building activities, Trekking, Fun games, BBQ, talent show, treasure hunt and one night camping at Biodiversity center.

With the support from TBC staff, World Earth Hour was observed by switching off all lights at 8:30pm on 24th March and children carried Glow sticks in total darkness to raise awareness on climatic change.





The main purpose of this camp is to explore various hidden talents within our children and also to strengthen their teamwork, which is a part of MA's established objectives towards Education.

MYTH BUSTERS

Myth Busters an innovative education activity for kids was conducted on 29th July 2018. There were around 50 participants for this event. The objective of this program is to explore and educate the kids in 4 different areas of Science, Culture, Fine arts and Sports.
